## Year 6 Barnstondale Activity Centre

To fulfil the curriculum aims, which are normally achieved on our residential visit, we have arranged for Y6 to enjoy an Activity day at Barnstondale Activity Centre on July 8<sup>th</sup> 2021.

During the day the children will be taking part in The Wildwood Challenge programme. Children will need to bring a packed lunch with them and a water bottle with their name clearly marked. The children will be outdoors for most of the day and therefore they do not need to wear their school uniform. They should however wear appropriate clothing for outdoor activities. E.g. tracksuit, sensible shoes (these may get muddy) and a waterproof coat.

The total cost of the trip is £32.00 per child. Due to Covid-19 restrictions we will require parents to drop their child(ren) at Barnstondale Activity Centre between 9:00am and 9:15am where they will register and collect them from Barnstondale at 3:10pm. Payment in full should be made via Parent Pay. Alternatively, you can pay smaller instalments as long as the full amount is paid by 2<sup>nd</sup> July, 2021.
